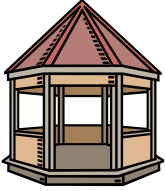
2011 Rules and Regulations (Please keep this page for your records.)

DEXTER DAZE EXHIBITORS AGREE:

1. All items in the park must be **HAND-CRAFTED** by the exhibitor. (Retail items and Businesses will be in the surrounding areas of Monument Park.)
2. Objectionable items (such as guns of any kind) will be removed at the request of the Dexter Daze Committee.
3. All displays will be open by 9:00am August 12 & 13, 2011
4. There will be no designated exhibitor parking area. Parking will be available on local streets and lots on a first come basis.
5. To register at the Monument Park Gazebo by 9:00am Friday, August 12, 2011.
6. To vacate the booth promptly after the show and leave the booth area clean.
7. To remain open until the close of the show on Saturday, August 13, 2011 (8:00pm).
8. Cancellations after July 15, 2011 will result in forfeiture of booth fee. Cancellations before July 15, 2011 will be refunded less \$15 IF THE BOOTH CAN BE REASSIGNED. Refunds will be mailed within two weeks of the close of the show.
9. Booth assignments are final. Normally, there will be no re-locations after assignments.
10. To provide their own insurance. Any and all claims must be waived, however incurred, against the Village of Dexter, The Dexter Daze Committee or members thereof.
11. That any and all property of the exhibitor is the sole responsibility of the exhibitor while participating in the Dexter Daze show.
12. Exhibitors will not be allowed to offer eatable or drinkable items not previously approved. Exhibitors may not provide services, items or entertainment not approved. Exhibitors may offer penny candy items at their booths. This includes Tootsie Rolls, individual mints, gum, and other similar type items.
15. No lit candles in any exhibitor booths per The Village of Dexter Fire Marshall.
16. No smoking in or outside of exhibitor booth area.
17. Booth spaces may **not** be Sub-leased.
18. Please mark desired booth location on application form. Please note that an updated booth map is attached.

DEXTER DAZE COMMITTEE AGREES:

1. To promote the craft show locally and also on DexterDaze.Org website.
2. To furnish contracted space, reserving the right to modify in the best interests of the show. (No tent, tables or chairs are provided.)
3. To notify the crafters of acceptance or rejection by July 15th, 2011. Notice will be sent via postcard. Crafters will be notified their booth assignment by August 1, 2011. Notice will be sent in SASE envelope provided by exhibitor with application. Booth assignments and location will be at the discretion of the Dexter Daze Committee.
